Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1- Bid date is hereby extended to July 16, 2024

Item 2- RFI's and Responses follow:

RFI #1: What is the current traffic detection type?

R. There are a few types of existing traffic detection currently present on this project. Loops at both Tampa St and Nebraska Ave, video detection at Florida Ave, and microwave/radar at I-275 SB off-ramp. These same types are reflected in the signal plans with adjustments to accommodate the proposed improvements.

RFI #2: I-1.05 TIME FOR COMPLETION on page I-1b is blank, would you please clarify?

R. Contract Duration is 390 calendar days.

RFI #3: I-1.06 LIQUIDATED DAMAGES on page I-1b is blank, would you please clarify?

R: The actual rate for "liquidated damages is set at the rate of \$1,685
Per the LAP DIVISION I SPECIFICATIONS FOR CLASS D PROJECTS.
(Rev. 3/26/2024) (FA. 3/29/2024) (07/24).

RFI #4: The FDOT LAP Contract Number on page I-1d is blank, would you please provide?

R. : The FDOT LAP No. is 436640-1-58-01
The Federal Aid Contract No. is D720-048-B.

RFI #5: Please provide a spec for the channelizing curb.

R: Channelizing curb shall be listed on the FDOT APL, section 703. Please note that the channelizing curb was not intended to have delineators attached, and only the Zicla product is shown without delineators.

RFI #6: The pay item for FC12.5 C states with rubber. Rubber is no longer used. Do you want the 76-22 binder?

R: Please disregard the term "Rubber" for FC12.5. FC12.5 shall be per section 337 of the FDOT STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION.

RFI #7: The bid form for subject project has the MOB & MOT prices filled out.

R: Replace Proposal page P-2 with attached P-2R

Item 2: Delete from the Specific Provisions: **SPT-2.13 PROJECT PHOTOGRAPHS:**

All other provisions of the Contract Documents and Specifications not in conflict with this Addendum shall remain in full force and effect.
