

RESOLUTION NO. 2024 - 881

A RESOLUTION AUTHORIZING AGREEMENTS FOR CONSULTANT SERVICES IN AN AMOUNT NOT TO EXCEED \$5,000,000 BETWEEN THE CITY OF TAMPA AND APPLIED SCIENCES CONSULTING, INC., THE CITY OF TAMPA AND LAND & WATER ENGINEERING SCIENCE, INC., THE CITY OF TAMPA AND GEOSYNTEC CONSULTANTS, INC., THE CITY OF TAMPA AND JACOBS ENGINEERING GROUP INC., THE CITY OF TAMPA AND JOHNSON, MIRMIRAN & THOMPSON, INC., AND THE CITY OF TAMPA AND STANTEC CONSULTING SERVICES INC. IN CONNECTION WITH CONTRACT 24-D-00020 CITYWIDE WATERSHED MASTER PLANNING PROGRAM; AUTHORIZING THE MAYOR OF THE CITY OF TAMPA TO EXECUTE SAME; PROVIDING AN EFFECTIVE DATE.

WHEREAS, via the competitive selection process in accordance with Florida Statutes Section 287.055, Consultants' Competitive Negotiation Act ("CCNA"), as applicable, the City of Tampa ("City") selected Applied Sciences Consulting, Inc., Land & Water Engineering Science, Inc., Geosyntec Consultants, Inc., Jacobs Engineering Group Inc., Johnson, Mirmiran & Thompson, Inc., and Stantec Consulting Services Inc. ("Firm") to provide professional services in connection with 24-D-00020 Citywide Watershed Master Planning Program ("Project") as detailed in the Agreement for Consultant Services (Agreement); and

WHEREAS, the Request for Qualifications for the Project allowed the City to select multiple firms for the delivery of the Project; and

WHEREAS, the Agreement with Applied Sciences Consulting, Inc. shall be designated 24-D-20001, the Agreement with Land & Water Engineering Science, Inc. shall be designated 24-D-20002, the Agreement with Geosyntec Consultants, Inc. shall be designated 24-D-20003, the Agreement with Jacobs Engineering Group Inc. shall be designated 24-D-20004, the Agreement with Johnson, Mirmiran & Thompson, Inc. shall be designated 24-D-20005, and the Agreement with Stantec Consulting Services Inc. shall be designated 24-D-20006; and

WHEREAS, the City desires to enter into each Agreement with each Firm to provide certain professional services that includes, but is not limited to, watershed evaluation, floodplain analysis, alternatives analysis, and development of future capital improvement projects; and

WHEREAS, it is in the best interest of the City of Tampa to enter into each Agreement.

**NOW, THEREFORE,
BE IT RESOLVED BY THE CITY COUNCIL
OF THE CITY OF TAMPA, FLORIDA, THAT:**

Section 1. The Agreements between the City of Tampa and Applied Sciences Consulting, Inc., Land & Water Engineering Science, Inc., Geosyntec Consultants, Inc., Jacobs Engineering Group Inc., Johnson, Mirmiran & Thompson, Inc., and Stantec Consulting Services Inc., in connection with Contract 24-D-00020 Citywide Watershed Master Planning Program, copies of which are attached hereto and made a part hereof, are authorized and approved in their entirety or in substantially similar form.

Section 2. The Mayor of the City of Tampa is authorized and empowered to execute, and the City Clerk to attest and affix the official seal of the City of Tampa to, said Agreement on behalf of the City of Tampa.


Section 3. This Resolution provides funding in the amount of \$5,000,000 for use by the Mobility Department for the Citywide Watershed Master Planning Program from within the Stormwater Improvement Assessment Capital Fund.


Section 4. The City Clerk shall file a fully executed copy of each Agreement in the official records of the City of Tampa as maintained by the Office of the City Clerk.
